You may apply a new Dependent Pass for your immediate family member (Parents, Spouse and Children only) only after you receive your Student Pass. Due to the strict document requirements which could cause delay in the application, you may bring your dependents to enter Malaysia <u>AFTER</u> you have fulfilled all the document requirements. Any consequences such as overstaying will be on your own responsibility.
